

Making your foldable



- 1. Make sure you have 6 pieces of white paper
- 2. Evenly space all 6 stack them on top of each other and then space them out
- 3. Fold over the layers so you end up with12 layers total
- 4. Staple the top edge to make sure it doesn't fall apart
- 5. Hole punch the top edge as well, so it doesn't get lost in your notebook
- 6. Now you're ready to label


